**ORDER PURSUANT TO RULE 1015(b)  
OF THE FEDERAL RULES OF BANKRUPTCY PROCEDURE AND  
N.D. TX L.B.R. 1015.1 DIRECTING JOINT ADMINISTRATION OF CASES**

Upon the Motion and Amended Motion, dated July 15, 2003 (the “Motion”), of Mirant Corporation and its affiliated debtors (collectively, the “Debtors”), as debtors in possession, for an order pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure and N.D. TX L.B.R. 1015.1 directing the joint administration of the Debtors’ chapter 11 cases for procedural purposes only, all as more fully set forth in the Motion; and upon consideration of the Affidavit of John Ragan in Support of First Day Motions and Applications; it appearing that the Court has jurisdiction over this matter; and it appearing that due notice of the Motion has been provided as set forth in the Motion and that no other or further notice need be provided; and it further appearing that the relief requested in the Motion is in the best interests of the Debtors and their estates and creditors; and upon all of the proceedings had before the Court; and after due deliberation and sufficient cause appearing therefor, it is

**ORDERED** that, the above-captioned chapter 11 cases be, and they hereby are, consolidated for procedural purposes only and shall be jointly administered by the Court; and it is further


**ORDERED** that, nothing contained in this order or the Motion shall be deemed or construed as directing or otherwise affecting a substantive consolidation of the above-captioned cases; and it is further

**ORDERED** that, pleadings in the above chapter 11 cases shall be required to bear a caption substantially in the form as the caption attached hereto as Exhibit A; and it is further

**ORDERED** that, a docket entry shall be made in each of the above-captioned cases substantially as follows:

“An order has been entered in this case directing the procedural consolidation and joint administration of Mirant Corporation, Case No. 03-46590, with this case and the docket in Case No. 0303-46590 should be consulted for all matters affecting this case.”
