**NOTICE OF EFFECTIVE DATE OF REJECTION OF NONRESIDENTIAL  
REAL PROPERTY LEASE OF TURNER ARENA OPERATIONS, INC.**

PLEASE TAKE NOTICE that on August 29, 2003, the Debtors filed and properly served the Motion of Debtors to Reject Unexpired Lease of Nonresidential Real Property of Turner Arena Operations, Inc. (the "Rejection Motion"). The Rejection Motion sought Bankruptcy Court authority to reject the Philips Arena Suite License Agreement dated as of the 2<sup>nd</sup> day of May, 2000 Between Turner Arena Operations, Inc. (the "Counterparty") and Mirant Corporation as assignee of Southern Energy, Inc. (the "Lease") pursuant to the rejection procedures established in the Amended Order Regarding Motion of Debtors for an Order Pursuant to Sections 365 and 554 of the Bankruptcy Code Authorizing and Approving a Procedure for the Rejection of Certain Executory Contracts (the "Order") entered by this Court on August 14, 2003.

Pursuant to the Order, the last day for the Counterparty to file an objection to the Rejection Motion was September 15, 2003. No objection was filed with the Court or received by the Debtors in

regard to the Rejection Motion. Therefore, the Lease was (and is) rejected effective as of September 15, 2003 and the Debtors, therefore, have no further obligations under the Lease.
